2015 ITS Georgia Wayne Shackelford Engineering Scholarship

Criteria

1. Students must be enrolled in an ABET accredited university in Georgia.
2. Each applicant shall submit a transcript for any college coursework completed (an unofficial transcript is acceptable). A GPA of 3.0 or higher is required.
3. The candidate should be currently enrolled in an undergraduate or graduate degree program in a transportation related field, such as civil engineering, urban planning, computer engineering or electrical engineering.
4. Applicants are asked to submit an essay (maximum of 1,000 words) in response to the following question:

In transportation, new data collection and connectivity technologies are creating incredible opportunities to improve the safety and efficiency of our vehicles and highways. Discuss at least two of the benefits and two of the challenges that these new technologies will present.

Deadlines:

September 25 – Responses Due

October 15 – Award winners notified (maybe)

October 29 – Awards presented at meeting at Georgia Tech

February 2016 – Main winners present their responses at February meeting
